DISCIPLINE CLUSTER AND WEIGHTING

RELATIONSHIP TO OTHER UNITS This is a specialisation unit in the Master of Educational Leadership and the Postgraduate Certificate in Educational Leadership.

PREREQUISITES:

UNIT DESCRIPTION

Spirituality is explored as a basic dimension of being human with emphasis on an informed understanding of Christian discipleship and the Jesus story. It investigates the relationship between spirituality and leadership within the faith-community of the school in the current cultural context and facilitates exploration of major challenges facing leaders in the contemporary Catholic and other faith-based schools.

LEARNING OUTCOMES

On completion of this unit students will be expected to be able to:

- 1. Express the spiritual dimension as intrinsic to personal and community life (Graduate attributes V1, V3 and V4);
- 2. Connect the spiritual to Christian discipleship and the life and practice of their faith, with an appreciation of today's inter-faith context (Graduate attribute V1);
- 3. Explore the mission of Jesus in the contemporary Australian context (Graduate attribute I1);
- 4. Reflect critically, in this light, on ministerial leadership appropriate to Catholic and other faith-based schools (Graduate attributes I1, I3 and P2);
- 5. Show an awareness of the Australian cultural context as it affects both spirituality and leadership (Graduate attributes P1, V1, V2 and V4); and
- 6. Explore major challenges facing leaders in Catholic and other faith-based schools (Graduate attribute 13).

On successful completion of this unit, students will have progressed in the development of the following ACU graduate attributes:

CONTENT

Topics will include:

- Perspectives of contemporary spirituality
- Perspectives in the history of Christian spirituality
- Jesus of history and the Christ of faith
- Leadership and Christian discipleship
- Spirituality and ecclesial belonging
- Australian culture and spirituality
- The "culture" of Australian Catholic education
- The nexus between leadership and spirituality
- Ministerial leadership in the Catholic or other faith-based school.

TEACHING ORGANISATION

In addition to lectures on the key concepts found in the literature, there will be opportunities for group discussion, private reflection and practical activities. Face-to-face teaching, conventional distance education materials and electronic modes of delivery may also be used. These methods will allow students to participate in an intense dialogue, using a variety of investigative methodologies, sorting through various sources and types of evidence to identify underlying patterns, structure or significance. These methods are also intended to engage students as active participants in the learning process and encourage them to become independent learners. There will be respect for students' views and responses, an understanding of an individual's knowledge, capabilities and backgrounds and a concern for the welfare and progress of individual students.

ASSESSMENT

There will be two or three assignments totalling 5,500 words. Length would depend on weighting. At least one would require a focus on real-life situations. Sample assignment topics could be:
